1. Introduction

The AIM Board Partners believe that the ethos of Houlton School (the academy) should value the central contribution of Christianity to Britain's history and heritage, and how this underpins the moral framework of the British values of Democracy, Rule of Law, Respect and Acceptance of Difference, and Individual Liberty.

The academy will follow the S.A.C.R.E. (Standard Advisory Councils for Religious Education) scheme, as interpreted by the local [Warwickshire LA syllabus for Religious Education](#). The Agreed Syllabus sets out what pupils are taught in religious education (RE) from ages 11 to 19. All maintained schools have a statutory duty to provide a broad and balanced curriculum which includes RE.

Academies and free schools are required through the terms of our funding agreement to make provision for the teaching of RE. We can choose to whether use the locally agreed syllabus but are not required to do so.

The Agreed Syllabus is reviewed every 5 years. The review is overseen by an Agreed Syllabus Conference (ASC), which has a similar membership to the SACRE. The Syllabus for Warwickshire schools was published in 2017. All documents are available to download from the link above.

The academy accepts the right of parents/carers to withdraw their children as a matter of conscience, although we encourage participation in our programme as Houlton's School does not have any particular religious character and its programme is **not** one of religious instruction in any particular faith. Religious Education will be taught to all year groups in the academy and will teach children **about** Christianity and other major world faiths and belief systems, and about people who have no particular faith.

The curriculum will recognise the links between RE and the pastoral ethos of the academy and with the programme of PHRSE. The academy ensures that a time for personal reflection takes place each day in tutor time and additionally each week through a programme of year group assemblies.

2. Assemblies

The programme for assemblies is set annually. Assemblies may make use of local religious figures, visiting speakers and other guests. However, they are usually led by a member of the Leadership Team.

All assemblies should aim to be positive and will always make explicit reference to at least one of the core British Values stated above.

3. Religious Education with the Curriculum

RE is a core part of the taught curriculum throughout the school and follows the agreed syllabus – see Curriculum Policy.

4. Other Curriculum Time

Teachers take opportunities that arise to discuss issues of religion, philosophy, morality and ethics

Pupils have access to a suitable place to pray or reflect during the day, should they so wish. This is located in the Transmission Hall on the ground floor near the SEND suite of accommodation.
