Clarification of before and after school arrangements at Houlton

You will be aware from <u>our published co-curricular programme</u>, that unlike many secondary schools, we have free, supervised provision available from 8:00am each morning (breakfast club in the Refectory) and a Study Support Club in the Centre for Communication (CfC) until 4:15pm. These are both supervised by our Associate Teacher, Miss Fleck, or one of our Teaching Assistants. Additionally, there are a number of clubs and activities that teachers volunteer their time to run after school until 4:15pm. However, as we are not a primary setting there is no formal, supervised wrap-around care before or after these times.

As previously communicated, pupils may arrive on campus earlier than 8:00am and may stay after 4:15pm if this supports working families travelling to school. However, our Front of House team are officially on campus from 8:00am-4:30pm each day, so pupils are not supervised outside of these times. As pupils mature and develop greater independence, they will likely not wish to stay at school out of hours and will increasingly make their own arrangements to be with friends, meet up at the local parks, meet together in town or make their own way home. If this is not possible, they may stay on campus and wait in the Refectory after 4:15pm, **but this will not be formally supervised** and will only be until 5:00pm **at the latest.** External lettings for the general public begin at 5:00pm; therefore, pupils should not be on campus after this time due to safeguarding.
